At the same time, the incorporating company changed its corporate name to OMCD TEK HUB S.p.A.; it is currently structured into 5 Divisions: FILMS, FILMS Riciclo, Celsia, Harditalia and UGP.

The **FILMS and FILMS Recycling Divisions** are specialized in design and production of RTP (ready to press) hard metal powder, design and production of hard metal products, storage and recovery of ferrous and non-ferrous metal scrap, brokering and trading of waste.

The **Celsia Division** in specialized in production of sintered electrical contacts, silver galvanization, production of sintered copper-tungsten, production of RTP (ready to press) tungsten powder mixtures with paraffin, recovery of metallic dangerous muds.

The **Harditalia Division** in specialized in design and production of hard metal products, design and production of inserts, tools for turning, milling and scarfing.

The **UGP Division** in specialized in grinding processing of hard metal products and sharpening of inserts.

OMCD TEK HUB S.p.A. is part of the OMCD Group, characterized by over 70 years of design and production experience in the hard world of sintered carbides. For this reason, the market has recognized for many years a position of leadership and unique reference in the world of hard metals.

In recent years, more and more space has been given to productions with a high technological and engineering content.
